- \$24.49 X 0.7734375 = \$18.941484375
- A \$10,000 Penalty X \$18.941484375 = \$189,414.84 Lawful Dollars
- A \$75,000 Penalty X \$18.941484375 = \$1,420,611.32 Lawful Dollars
- A\$250,000 Penalty X \$18.941484375 = \$4,735,371.09 Lawful Dollars
