



MEMBER COVENANT

AMG-PMA

The AMG-PMA is a non-commercial, non-political, private unincorporated association (“AMG-PMA”)

PURPOSE

I will gather as a friend, in trust with other friends, as a gift from eachother, to eachother, and for eachother. I am doing this for the express purpose of exploring, discussing and learning about protecting and stewarding property through sacred honor. I will do this by examining Law, history, the history of Law, rights, titles and interests. Both sacred and lawful (“Purpose”). *And sometimes I will explore at-law.*

MEMBER

A living man or woman with a completed Member Covenant including sufficient consideration described within this covenant, and accepted by AMG-PMA (“Member”).

MEMBER COVENANT

The private, unincorporated trust arrangement between the AMG-PMA and a member of the AMG-PMA (“Member Covenant”).

GOOD STANDING

A member granting a Member Covenant, while remaining in honor and in accordance with the Member Covenant and who has not breached the trust arrangement established within the Member Covenant (“Good Standing”)

MEMBERSHIP

A Member shall be conditionally granted certain rights and interests in the Purpose of the AMG-PMA, either month by month or year by year as further described below. Upon AMG-PMA acceptance of the Member Covenant with sufficient consideration (“Membership”)

Membership shall then be granted to Member and Member will accept the duties and obligations to the trust relations and shall begin Membership on the first day of the next month with Good Standing

MONTHLY MEMBERSHIP

Membership is sustained one month at a time; month by month (“Monthly Membership”)

ANNUAL MEMBERSHIP

Membership is sustained one year at a time; year by year (“Annual Membership”).

MEMBERSHIP ELECTION

Monthly Membership or Annual Membership shall be elected by Member when completing a Member Covenant, or at other times further described within the Member Covenant (“Membership Election”).

MEMBERSHIP ELECTION CHANGE AGREEMENT

Upon notice of request, Member can change Membership Election at any time by a separate written mutual arrangement between Member and AMG-PMA (“Membership Election Change Agreement”).

MEMBERSHIP GIFTS

To sustain Membership, a lawful consideration, described further below, shall be granted and conveyed by Member on a month by month or year by year basis accordingly (“Membership Gifts”).

GENERAL GIFTS

General gifts are any gift granted by Member which is intended to help the AMG-PMA sustain, grow, and/ or continue to provide value to the AMG-PMA Membership community, and which are not Membership Gifts. (“General Gifts”).

EQUITABLE ASSETS OF THE AMG-PMA

AMG-PMA will accept gifts as equitable assets of the AMG-PMA to satisfy the duties and obligations arising from stewarding the AMG-PMA, from the trust established in the Member Covenant with Members, and from the intent and purpose of the grantor of General Gifts if any.

MEMBERSHIP PERIOD

From the first day of the month after the month AMG-PMA grants a Membership to Member, until Membership is terminated either by Member or by AMG-PMA as further described below (“Membership Period”).

MEMBER MEMBERSHIP TERMINATION

Member may give notice of intent to extinguish Membership at any time without cause, at which point AMG-PMA duties and obligations, and, Member duties and obligations to the Member Covenant will extinguish at the end of the current month in which notice is given; except as further described under AMG-PMA Membership Materials below (“Member Membership Termination”).

AMG-PMA MEMBERSHIP TERMINATION

AMG-PMA may give notice of intent to extinguish Member's Membership at any time with cause, and Member duties and obligations, and, AMG-PMA duties and obligations to the Member Covenant will terminate. Such termination shall occur by AMG-PMA notice as either immediately or at the end of the current month which notice is given; except as further described under AMG-PMA Membership Materials below ("AMG-PMA Membership Termination").

AMG-PMA ACCEPTANCE ADDRESS

AMG-PMA will accept delivery of this Member Covenant and all Membership Gifts, and any General Gifts, at an address to be disclosed separately as an addendum to this Member Covenant, and may change from time to time with a 45 day notice.

When Member has decided to accept the Member Covenant and become a Member, Member will give notice by email to AMG-PMA and will then receive the AMG-PMA Acceptance Address by email. ("AMG-PMA Acceptance Address").

AMG-PMA ACCEPTANCE

Delivery to the AMG-PMA Acceptance Address of a properly completed Member Covenant with a sufficient consideration within the correct times expected.

From time to time, and with reasonable notice, AMG-PMA may change the acceptance address or provide electronic granting and conveyance alternatives. ("AMG-PMA Acceptance").

AMG-PMA ACCEPTANCE AND ACKNOWLEDGEMENT

Upon AMG-PMA Acceptance, AMG-PMA will provide a deed of acceptance and acknowledgement to Member (AMG-PMA A&A").

ACTIVE MONTH

The active month is measured from the first day to the last day of the current calendar month ("Active Month").

NEXT ACTIVE MONTH

The next active month is measured from the first day to the last day of the next calendar month after the Active Month ("Next Active Month").

ACTIVE YEAR

The active year is measured from the first day of the Next Active Month until the last day of the 12th calendar month after ("Active Year").

NEXT ACTIVE YEAR

The next active year begins on the next calendar day after the Active Year ends ("Next Active Year").

DELIVERY DATE

The delivery date for Member's Membership Gifts is the 21st day of the Active Month ("Delivery Date").

DELIVERY OF MEMBERSHIP GIFTS

Unless otherwise expressed by AMG-PMA, and notice given, the grant and conveyance of Membership Gifts must arrive no later than the Delivery Date in the Active Month; this ensures Membership continues uninterrupted throughout the Next Active Month ("Delivery of Membership Gifts").

**Please allow a few extra days when mailing because the 21st day of the month is the arrival date for Membership Gifts, ...and is not the mailing date.*

LATE DELIVERY

Delivery of Membership Gifts after the 21th day of the Active Month is a default in the Delivery of Membership Gifts ("Late Delivery").

**Late Delivery will likely cause a delay, not to exceed 7 days, for Member access to the Membership rights and AMG-PMA Materials during the Next Active Month. Member accepts this delay without recourse. If Late Delivery becomes a pattern of Late Delivery, this may be cause for temporary or permanent removal of Membership rights and interests in the AMG-PMA.*

NO DELIVERY

Delivery beyond the last day of an active month where a Membership is desired is cause for termination of Membership ("No Delivery"). A new Member Covenant may be required to participate again.

MONTHLY MEMBERSHIP GIFTS

To obtain a monthly membership with the AMG-PMA, I shall:

- 1) Grant, convey and deliver a minimum Membership Gift in the amount of \$5.00 lawful coin (*silver dollars / non cull*), or, 5 ozt .999 silver for Membership in the Next Active Month, and then I shall continue to grant and convey a minimum gift of \$3.00 lawful coin (*silver dollar / non cull*) or, 3 ozt .999 silver for each calendar month thereafter that Membership is elected by Member. Gifts beyond the minimum are encouraged but are not required to participate.

or,

- 2) Instead, I may grant and convey a minimum gift of \$170.00 USD as lawful money only [*demand 12 USC 411 where applicable*] in cash for the first month, and then I shall continue to grant and convey a minimum gift of \$100.00 USD as lawful money only [*demand 12 USC 411 where applicable*] in cash for each month thereafter. Gifts beyond the minimum are encouraged ("General Gifts"), but are not required to participate. Because of inflation and other fluctuations in fiat currency markets cash amounts may need adjustment from time to time with a 30 day notice to Member from AMG-PMA.

ANNUAL MEMBERSHIP GIFTS

To obtain an annual membership with the AMG-PMA, Member shall:

- 1) Grant, convey and deliver a minimum Membership Gift in the amount of \$32.00 lawful coin (*silver dollars / non cull*), or, 32 ozt .999 silver for the Next Active Year, beginning in the Next Active Month. Gifts beyond the minimum are encouraged but are not required to participate.

or,

- 1) Grant and convey a minimum gift of \$1,000.00 USD as lawful money only [*demand 12 USC 411 where applicable*] in cash for the Next Active Year beginning in the Next Active Month. Gifts beyond the minimum are encouraged but are not required to participate. Because of inflation and other fluctuations in fiat currency markets cash amounts may need adjustment from time to time with a 30 day notice to Member from AMG-PMA.

ELECTRONIC GIFTS

The provisions for electronic grants and conveyances of Membership Gifts and General Gifts may be added or removed at will by the AMG-PMA (“Electronic Gifts”).

MEMBER COVENANT UPDATES

From time to time the AMG-PMA council may recognize a need to update or modify the Member Covenant for all Members (“Member Covenant Updates”).

MEMBER RE-COVENANT

Because of Member Covenant Updates, Member may be required to re-covenant at any time during the Membership Period (“Member Re-Covenant”).

If Annual Members are required to re-covenant they will have the option to have any unused portion of their Annual Membership Gift returned should they disagree with the requirements of Member Covenant Updates.

NOTICE TO EXTEND MEMBERSHIP

Delivery of Membership Gifts shall be considered effective notice by Member to continue Membership uninterrupted into the Next Active Month, or Next Active Year accordingly (“Notice to Extend Membership”).

AMG-PMA MATERIALS

During the Membership Period, Member shall be exposed to or provided with certain electronic data property; including videos, video conferences, seminars, teleconferences, meetings, audio files, hyperlinks, passwords, emails, articles, and documents (“AMG-PMA Materials”).

AMG-PMA MATERIALS PROTECTIVE COVENANT

Unless otherwise expressed by AMG-PMA and notice given to Member, AMG-PMA Materials are to be considered protected property under a paramount protective covenant between Member and AMG-PMA at all times, even after Member Membership

Termination, or AMG-PMA Membership Termination (“AMG-PMA Materials Protective Covenant”).

The intent is to make membership and learning materials available to Member, but to prohibit upload and distribution of certain protected AMG-PMA Materials outside the AMG-PMA and its active Membership community.

Violation of the Protective Covenant shall be considered permanent dishonor.

AMG-PMA MATERIALS EXCEPTIONS

AMG-PMA will give express notice if any AMG-PMA Materials are NOT under the AMG-PMA Materials Protective Covenant (“AMG-PMA Materials Exceptions”).

RIGHTS OF MEMBER TO AMG-PMA MATERIALS

The AMG-PMA will make AMG-PMA Materials available to Member, Member has the right to study any AMG-PMA Materials in the manner they are provided to Member, and while they are made available to Member by AMG-PMA. From time to time AMG-PMA may allow possession of AMG-Materials, and unless otherwise expressed in writing by AMG-PMA, possession shall not be considered a grant of title or exception, but rather a custody and stewardship of protected trust relations to the property (“Rights of Member to AMG-PMA-Materials”).

TITLE TO AMG-PMA MATERIALS

Although access to, or possession of AMG-PMA materials may be granted to Member during the Membership Period, the titles to AMG-PMA Materials shall always remain with AMG-PMA (“Title to AMG-PMA Materials”).

Member is not granted any right to independently record, ...or to upload or distribute AMG-PMA Materials anywhere outside of the AMG-PMA resources and its Members, unless expressly by AMG-PMA Materials Exceptions.

Member comments, and participation in the creation of AMG-PMA materials become unrestricted property of the AMG-PMA as AMG-PMA Materials. Member waives any and all claims to voice, image, or text posts, except those retained in Member Materials Grants below.

MEMBER MATERIALS GRANTS

Member may grant digital data of seminars, webinars, audio recordings, documents, emails, articles, etc... to the AMG-PMA for the benefit of other Members, Member Materials Grants shall be conducted privately between granting Member and AMG-PMA prior to any such grant.

MEMBER PRIVATE INFORMATION

During the Membership Period, Member shall be exposed to, or provided with, certain member names, phone numbers, case numbers, addresses and other private circumstances.

Member Personal Information shall be treated with the highest level of privacy and protective respect. Member shall not upload or distribute any Member Personal Information outside of the AMG-PMA, or Membership, without express permission of AMG-PMA AND the Member directly exposed by the information (“Member Private Information”).

MEMBER KNOWLEDGE

During Membership, Member will develop their own interpretation and understanding from AMG-PMA Materials (“Member Knowledge”). Member Knowledge is the sole creation and property of the Member, and Member is not prohibited from expressing that knowledge in an original customized manner as they deem necessary.

AMG-PMA SCHEDULING

The AMG-PMA shall provide all scheduling of meetings and other events which benefit Member. AMG-PMA from time to time may elect to have Members participate in setting scheduling related issues (“AMG-PMA Scheduling”).

AMG-PMA SPECIAL EVENTS

From time to time the AMG-PMA may have special guests or special events which are beyond the rights which arise from Membership Gifts, (“AMG-PMA Special Events”).

Member will be given advance notice when such AMG-PMA Special Events are occurring, and shall benefit from a private membership consideration when possible as determined by the AMG-PMA.

GOVERNANCE

The jurisprudence of this covenant shall be exclusive equity, and the Member Covenant established and enforced by authorized council members of the AMG-PMA, and by Member voting as determined by the AMG-PMA.

EXTERNAL INFLUENCE

Using political affiliations and foreign laws to disparage Members, or to intimidate or coerce Member voting must remain outside the Membership and the AMG-PMA at all times (“External Influence”). Violations can be cause for AMG-PMA Membership Termination and may be cause for temporary or permanent dishonor.

AMG-PMA DISCLAIMER

AMG-PMA is an archivist and community developer and event manager. AMG-PMA, or presenters participating in the AMG-PMA are not ever providing a legal service, nor ever offering legal advice for any individual legal situation. Nor is it claimed by AMG-PMA that AMG-PMA Member Materials or Member Knowledge is a substitute for legal advice from a licensed attorney at-law. AMG-PMA is not a B.A.R. Association member, nor will any AMG-PMA presenter knowingly be. AMG-PMA Materials are for academic purposes only to be used at Member’s own risk without liability to AMG-PMA, its principals, or to other Members.

The AMG-PMA makes no warranty to the success or failure of Member Knowledge at any time, either before, during or after the Membership Period. Member will discern the AMG-PMA Materials for contemplation and intellectual exercise and develop and use Member Knowledge at Member's own risk only.

All AMG-PMA Materials and events have this Disclaimer referenced to and incorporated therein whether or not they are present in such materials. ("AMG-PMA Disclaimer")

MEMBER HOLD HARMLESS

Member shall hold harmless and indemnify AMG-PMA for any and all injury sustained from using Member Knowledge and from being exposed to AMG-PMA Materials; All AMG-PMA Materials and events have this hold harmless referenced to and incorporated therein whether or not they are present in such AMG-PMA Materials ("Member Hold Harmless").

NON-COMMERCIAL ASSOCIATION

Membership and Member activities in the AMG-PMA, and any grant or conveyance of gifts to AMG-PMA or to any other Members, and other consideration exchanged between members, or between members and the AMG-PMA must always be lawful, therefore not commercial, not commerce, and is not "The exchange of goods, products, services, or public property of any kind. Further, it is not the buying, selling, and exchange of articles, or the transportation of persons and property by land, water, and air for any commercial interest or purpose at any time under this Member Covenant."

My membership and activities within the AMG-PMA, and, any grant or conveyance of gifts to AMG-PMA or other Members, or other consideration exchanged is not an association in or with "Affecting Commerce," "Chamber of Commerce," "Interstate Commerce," "Foreign Commerce," Interstate Commerce Act," "Interstate Commerce Commission," "Intrastate Commerce," nor any other Relative of Commerce at any time hereunder. ("Non-Commercial Association")

DENOGRATION

Constructive discussion, including differing opinions, is welcomed, but no name-calling, insults, derogatory remarks, or denigrations will be tolerated ("Denogration").

AMG-PMA COUNCIL

The AMG-PMA shall be responsible for the equitable management of the AMG-PMA ("AMG-PMA Council"), of which Member agrees to honor any resolutions

Throughout the Membership Period, Member will adhere to any resolutions provided by AMG-PMA, and if Member disagrees with any resolutions, and before dishonoring those resolutions, will petition for appeal and will be heard by that council within 30 days.

Acceptance of this Member Covenant is by my own free will using good reason and good conscience.

INCLUSION

AMG-PMA Membership will recognize any man or woman (irrespective of genetic origin, spiritual or philosophical orientation, etc.) who is in accordance with the maxims of exclusive equity, and with the Member Covenant.

NOTICES

Throughout the Membership Period where notice is required, notice shall be considered given by Member when email is received at Support@AmericanMeetingGroup.com or at the Acceptance Address, or other email address or mailing address which AMG-PMA may change to from time to time, and notice of receipt given by AMG-PMA. Without notice of receipt given by AMG-PMA it shall remain the duty of Member to obtain it.

Notice shall also be considered given by AMG-PMA when email is received at the Member eMail Address provided below by Member, and which also may be changed from time to time with notice given, and shall take effect when Member provides notice of receipt. Without notice of receipt given by Member it shall remain the duty of AMG-PMA to obtain it 3 times. (“Notices”).

AMG-PMA DUTIES TO MEMBER

The AMG-PMA will provide AMG-PMA Materials to its Members, and ongoing access to those materials. The AMG-PMA will also provide office and accounting support to the Members (“Member Support”), and a council for hearing Member complaints, and settling Member controversies (“AMG-PMA Council”). The AMG-PMA will also work towards improving the number of members and the quality of the learning experiences of the Members (“Membership Growth and Development”), and shall keep the learning environment orderly and conducive to the Purpose of the AMG-PMA.

GRANT AND CONVEYANCE

I hereby grant and convey the amount of \$5.00 in lawful coin, or 5ozt .999 Silver, or \$170.00 USD [per 12 USC 411 where applicable] as consideration for my Membership Gift, which secures my Membership rights from the 1st day of the Next Active Month until the last day of the Next Active Month.
